Particular attention is paid to self/co-regulation, affect management, and self-care skills both for the people being served and the providers themselves.

The importance of serial evaluations will be illustrated with a real example to demonstrate what to expect with the natural progression of the disease. #### INTRODUCTION TO MOTIVATIONAL INTERVIEWING
